

# Magical Cruise Vacation Sweepstakes

## OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**MUST BE 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY. U.S. LAW GOVERNS. VOID WHERE PROHIBITED BY LAW.**

**SWEEPSTAKES PERIOD.** The Magical Cruise Vacation sweepstakes ("**Sweepstakes**") begins at 2:00 PM Eastern Time ("ET") on March 8, 2024 and ends at 11:59 PM ET on April 12, 2024 (the "**Sweepstakes Period**").

**HOW TO ENTER.** There are two (2) ways to submit an entry during the Sweepstakes Period:

**1. By Listening to SiriusXM's Disney Hits on the SiriusXM App:**

Listen to the Disney Hits channel on the SiriusXM mobile app (the "**SiriusXM App**") for at least one (1) second and click on the link in the on-screen pop-up notification in the SiriusXM App to access the entry form and complete and submit your Entry. You must download the latest version of the SiriusXM App to receive the pop-up notification.

**2. Without listening on the SiriusXM App:**

To submit an entry if you do not have a subscription to SiriusXM to access the eligible listening channel or do not wish to enter using the SiriusXM App, print your first name, last name, postal address, phone number and email address on a 3x5 card or piece of paper and mail it in an envelope with proper postage to: **Magical Cruise Vacation Sweepstakes, P.O. Box 1948, South Hackensack, NJ 07606**. Your mail-in entry must be postmarked no later than April 12, 2024 and received by Sponsor (as defined below) no later than April 19, 2024.

Limit one (1) entry per person. Successful submission of all required information shall be considered an "**entry**" for the "**Entrant**." In the event of a dispute over the identity of an online Entrant, the entry will be deemed submitted by the authorized account holder of the e-mail account of the e-mail address submitted at time of entry. "**Authorized account holder**" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

**CONDITIONS OF ENTRY / ELIGIBILITY TO WIN.** Entrants agree to abide by the terms of these Official Rules and by the decisions of Sponsor which are final. This Sweepstakes is open only to individuals who meet ALL of the following qualifications: (i) is a legal resident of the United States, the District of Columbia, or Puerto Rico; and (ii) is at least 18 years of age at time of entry. **PRIZE.** One (1) Prize will be awarded using the selection process described below and satisfaction of the eligibility requirements set forth above:

- One (1) four (4)-night *Disney Cruise Line* vacation for winner and up to three (3) guests, to be taken aboard the Disney Wish ("**Vacation Package**" or "**Prize**"), departing from Port Canaveral, FL (the "**Cruise Departure Port**"). Prize includes:
  - One (1) stateroom aboard the Disney Wish (location/category at the discretion of *Disney Cruise Line*) with a maximum occupancy of four (4) people;
  - All meals onboard the Disney Wish (excluding specialty and fine dining); and
  - Pre-paid onboard gratuities for the stateroom host/hostess, dining room server, assistant server, and head server.
  - If the winner resides outside 250 miles of the Cruise Departure Port, Prize shall also include:
    - Up to four (4) roundtrip coach airfares (with possible layovers) for winner and three (3) guests between the major U.S. gateway airport closest to the winner's residence as determined by Disney ("**Departure Airport**") and Orlando International Airport in Orlando, FL ("**Arrival Airport**");
    - One (1) standard room with a maximum occupancy of four (4) persons for winner and three (3) guests at a Walt Disney World® Resort hotel (hotel selection at the discretion of *Disney Cruise Line*) for one (1) night prior to the ship's departure; and
    - Ground transportation for up to four (4) persons from airport to hotel and hotel to cruise port and back to airport.

The actual value of the Vacation Package may vary depending on point of departure and fluctuations of rates and airfares (if applicable).
