CONTEST PERIOD. The SiriusXM MLS All Star Game contest ("**Contest**") will begin at 9:00 AM eastern daylight time ("**ET**") on July 21, 2026 and end at 12:00 PM ET on July 23, 2026 (the "**Contest Period**").

HOW TO PARTICIPATE. On July 21, 2026 and July 22, 2026 (each, a "**Daily Contest**"), eligible subscribers can enter that Daily Contest by listening to "The Football Show" show on SiriusXM FC Radio (Channel 157), which airs from 9:00 AM ET to 12:00 PM ET ("**Show**"), and listen for your cue to call in to (877) 629-4614. Each caller whose call is answered will be preliminarily screened for the eligibility requirements stated herein, including subscription status, age and prior prizes won, and availability to participate in the Face Off (as defined below) if declared a Finalist (as defined below). If a caller does not satisfy the stated eligibility requirements or is unable or unwilling to participate in the Face Off, another caller will be selected, at Sponsor's discretion. A caller cleared by this process will be considered a "**Contestant**." The first selected Contestant for each Daily Contest will be asked a Major League Soccer trivia question. If the first Contestant is unable to correctly answer the question, another Contestant will be selected using the same process described above until a Contestant correctly identifies the answer. The first Contestant to correctly answer the question in each Daily Contest will be determined a "**Finalist**." The two Finalists will then participate in a head-to-head "**Face Off**" round at or about 12:00 PM ET on July 23, 2026, where they will be required to call in to the Show and answer five (5) Major League Soccer trivia questions. The Finalist who correctly answers the most trivia questions will be the "**Winner**." If the Finalists correctly answer the same number of trivia questions, they will be asked additional questions until one Finalist correctly answers a question and the other Finalist does not. The Winner is subject to eligibility verification that may occur after winning the Face Off. If the selected Winner is deemed ineligible, that person will be notified of their ineligibility and will not have any right to any Prize.
