**OFFICIAL RULES**

Successful submission of all required information shall be considered an "**Entry**" and the person submitting the Entry, the "**Entrant**." Proof of submission will not be deemed to be proof of receipt. Sponsor will not be responsible for any lost, late, illegible, misdirected or postage due mail. All Entries become the property of Sponsor and will not be acknowledged or returned. **LIMIT ONE (1) ENTRY PER PERSON.** Multiple entries submitted by a single person during the Entry Period shall render all of such person's entries void and ineligible.
