

## SiriusXM Aviation Spring 2026 Survey Sweepstakes

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES IS SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED BY LAW.**

**THIS SWEEPSTAKES IS NOT OPEN TO THE PUBLIC.**

**1. ENTRY PERIOD:** The Spring 2026 SiriusXM Aviation Survey Sweepstakes (“**Sweepstakes**”) begins at 8:00 a.m. Eastern Time (“**ET**”) on May 4, 2026 and continues through 11:59 p.m. ET on May 15, 2026 (the “**Entry Period**”).

**2. ELIGIBILITY:** This Sweepstakes is open to invited survey recipients who are residents of the 50 United States or the District of Columbia and are at least 18 years of age or older (each an “**Entrant**”). Employees of Sirius XM Radio LLC (“**Sponsor**”) or any of its subsidiaries, affiliates, contractors, or advertising or promotion agencies or any other entity involved in the marketing or promotion of the Sweepstakes, or a member of the immediate family or household (whether or not related) of any such employee, are not eligible.

**3. HOW TO ENTER:** Complete Sponsor’s survey (“**Survey**”) and follow the on-screen instructions to register and submit your entry into the prize drawing during the Entry Period (an “**Entry**”). Limit one (1) Entry per person during the Entry Period. All Entries are subject to verification. Proof of completion of the Survey does not constitute proof of Entry. By submitting an Entry in the Sweepstakes, Entrant agrees to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all matters pertaining to the Sweepstakes.

**4. PRIZES/ODDS:** Prize: One (1) Grand Prize winner will receive a \$250.00 Amazon eGift Card. Approximate Retail Value (“**ARV**”) of the Grand Prize is \$250.00. Two (2) First Prize winners will each receive a \$100.00 Amazon eGift Card. ARV of each First Prize is \$100.00. **Total ARV of all prizes is \$450.00.** Odds of winning depend on the number of eligible Entries received during the Entry Period. Taxes, if any, are the sole responsibility of each winner. An IRS Form 1099-MISC will be issued as required by law. No substitution, cash redemption or transfer of the right to receive a prize or any prize component is permitted, except in the discretion of Sponsor, which has the right to substitute the prize or any prize component with a prize or prize component of equal or greater monetary value selected by Sponsor in its discretion. The prize consists only of the items expressly specified in these Official Rules. All expenses or costs associated with the acceptance or use of the prize or any prize component (including, without limitation, streaming or mobile device, Internet connection and/or data costs) are the responsibility of the winner. Gift cards are subject to the terms and conditions of the issuer. Prizes are awarded “as is” and without any

warranty, except as required by law. In no event will more than the number of prizes stated in these Official Rules be awarded.

**5. WINNER SELECTION:** Winners will be selected in a random drawing, from among all eligible entries, on or about May 29, 2026. The drawing will be conducted by Sponsor whose decisions are final and binding. Sponsor will attempt to notify all potential winners on or about June 2, 2026 after the drawing at the email address provided during the Entry registration process. Sponsor is not responsible for any change of email address by Entrants. All winners are subject to verification for eligibility and compliance with the Official Rules prior to prize award. Winners may be required complete and return an Affidavit of Eligibility/Release of Liability and, if legally permissible, a Publicity Release, and any other documentation provided by Sponsor in connection with verification of the winner's eligibility and confirmation of the releases, and grant of rights set forth in these Official Rules ("**Verification Documents**") as a condition of receiving a prize. If requested, winners must respond to Sponsor's initial notification attempt within the time frame indicated in the notification and must complete and return to Sponsor any required Verification Documents within 3 business days after the Verification Documents are provided to the winner. If any winner fails to respond to any notification attempt within the time period indicated in the notification above or if any attempted notification is returned as undeliverable, or if any winner fails to complete and return any required Verification Documents within the time required (if requested), or if any winner does not meet the eligibility requirements or does not otherwise comply with these Official Rules, the winner may be disqualified and an alternate winner may be selected, at Sponsor's sole discretion from among the remaining eligible entries. All winners are potential winners until verified and prize is awarded.

**6. GRANT OF RIGHTS:** By accepting a prize, each winner irrevocably grants to Sponsor and its subsidiaries and affiliates, agents and licensees, and each of their respective successors and assigns (collectively, the "**Licensees**") the right to use, display, publish, perform, and broadcast the Entrant's name, likeness, voice, biographical information and statements attributed to the Entrant ("**Publicity Rights**"), in perpetuity, throughout the world, in all media and formats whether now or later known or developed (including without limitation via Sponsor's and third-party websites, audio streaming service, and social media and digital channels), for commercial purposes and any other purposes (including, without limitation, advertising and promotion), without further notice or compensation, unless prohibited by law.

**7. RELEASE AND LIMITATION OF LIABILITY:** To the fullest extent permitted by applicable law, each Entrant releases and agrees to hold harmless each of the Licensees, Amazon.com, Inc., Qualtrics, LLC and all other companies involved in the development, operation or marketing of the Sweepstakes or exercise of the rights in herein, the provision of any prize or any component of any prize, and the successors and assigns of each of the foregoing, and their directors and officers, without limitation (the "**Released Parties**") from and against any and all claims, causes of action and liabilities of any kind that the Entrant ever had, now has or might in the future have arising out of or relating to the Sweepstakes, participation in the Sweepstakes, the use of or inability to use the website, the acceptance, receipt, participation in or use of any prize or any component thereof and/or any use of the Entrant's Publicity Rights pursuant to these Official

Rules, including without limitation any and all claims, causes of action and liabilities (a) relating to any personal injury, death or property damage or loss sustained by any Entrant or any other person, (b) based upon any allegation of violation of the right of privacy or publicity, copyright infringement, misappropriation, defamation or violation of any other personal or proprietary right or (c) or based upon any allegation of a violation of any law, rule or regulation relating to personal information or data security. Each Entrant agrees not to assert any such claim or cause of action against any of the Released Parties. Each Entrant assumes the risk of, and all liability for, any injury, loss or damage caused, or claimed to be caused, by participation in this Sweepstakes, the use of any Sweepstakes-related website, or the provision, acceptance or use of any prize or prize component. The Released Parties are not responsible for, and will have not have any liability in connection with, (v) any typographical, printing, production, distribution or other error in the administration of the Sweepstakes or in the announcement of prizes or winners, (w) late, lost, delayed, illegible, damaged, corrupted or incomplete entries, incorrect or inaccurate capture of, damage to, or loss of Entries, entry information, or any other human, mechanical or technical error of any kind relating to the operation of the website, communications or attempted communications with any Entrant, the submission, collection, storage or processing of entries or the administration of the Sweepstakes, (x) any “act of god” or other force majeure event outside of Sponsor’s control that may cause any postponement or cancellation of any prize-related activity or interfere with, delay or prevent the provision of any prize, (y) undeliverable e-mails resulting from any form of active or passive e-mail filtering by an Entrant’s Internet service provider and/or e-mail client or for insufficient space in Entrant’s e-mail account to receive e-mail or (z) any damage to any computer system resulting from participation in or accessing or downloading information in connection with the Sweepstakes.

**8. FORCE MAJEURE:** Sponsor has the right, in its sole discretion, to modify these Official Rules (including without limitation by adjusting any of the dates and/or timeframes stipulated in these Official Rules) and to cancel, modify or suspend this Sweepstakes at any time, including without limitation if a virus, bug, technical problem, Entrant fraud or misconduct or other cause beyond the control of Sponsor corrupts or impacts in any way the administration, integrity, security or proper operation of the Sweepstakes or if for any other reason Sponsor is not able to conduct the Sweepstakes as planned (including without limitation in the event the Sweepstakes is interfered with by any fire, flood, epidemic, pandemic, virus, earthquake, explosion, labor dispute or strike, act of God or of public enemy, communications failure, riot or civil disturbance, war (declared or undeclared), terrorist threat or activity, federal, state or local law, order or regulation or court order) or in the event of any change to the terms governing the use of the website or the application or interpretation of such terms. In the event of termination or suspension of the Sweepstakes, a notice will be posted on the Sweepstakes website and Sponsor reserves the right to award or not award any prize in its sole discretion.

**9. GENERAL RULES:** Sponsor has the right, in its sole discretion, to disqualify or prohibit from participating in the Sweepstakes any individual who, in Sponsor’s discretion, Sponsor determines or believes (i) has tampered with the entry process or has undermined the legitimate operation of the Sweepstakes survey website or the Sweepstakes by cheating, hacking, deception or other unfair practices, (ii) has engaged in conduct that annoys, abuses, threatens or harasses any other

Entrant or any representative of Sponsor and/or Administrator or (iii) has attempted or intends to attempt any of the foregoing. ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE ASSOCIATED WITH THIS SWEEPSTAKES OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAW. SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR HAS THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) FROM ANY PERSON INVOLVED TO THE FULLEST EXTENT PERMITTED BY LAW. The use of agents or automated devices, programs or methods to submit entries is prohibited and Sponsor has the right, in its sole discretion, to disqualify any Entrant that it believes may have been submitted using such an agent or automated device, program or method. In the event of a dispute regarding who submitted an Entry, the entry will be deemed to have been submitted by the registered user of the e-mail account provided in connection with the Entry. All federal, state and local laws and regulations apply. These Official Rules may not be reprinted or republished in any way without the prior written consent of Sponsor.

**10. DISPUTES:** By entering the Sweepstakes, each Entrant agrees, to the maximum extent permitted by applicable law, that (a) any and all disputes, claims and causes of action arising out of or connected with the Sweepstakes or the provision, acceptance and/or use of any prize or prize component will be resolved individually, without resort to any form of class action; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorneys' fees; (c) under no circumstances will any Entrant be permitted to obtain any award for, and each Entrant hereby waives all rights to claim, punitive, special, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than for actual out-of-pocket expenses, and (d) each Entrant's sole and exclusive remedy with respect to any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes will be an action at law for the recovery of actual sustained monetary damages only, and in no event will the Entrant have the right to enjoin or otherwise interfere with the exercise by the Licensees of any of the rights granted in these Official Rules or terminate or rescind any of the rights granted in these Official Rules. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the respective rights and obligations of the Entrants and Sponsor in connection with the Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of New York without giving effect to any choice of law or conflict-of-law rules or provisions that would cause the application of the laws of any jurisdiction other than the State of New York. Any legal proceedings arising out of this Sweepstakes or relating to these Official Rules shall be instituted only in the federal or state courts located in New York County in the State of New York, waiving any right to trial by jury, and each Entrant consents to jurisdiction therein with respect to any legal proceedings or disputes of whatever nature arising under or relating to any of the foregoing. In the event of any conflict between these Official Rules and any Sweepstakes information provided elsewhere (including but not limited in advertising or marketing materials), these Official Rules shall prevail.

**11. USE OF INFORMATION:** By participating in the Sweepstakes, each Entrant agrees that information submitted via the survey website in connection with the Sweepstakes will be subject to Sponsor's Privacy Policy available at <https://www.siriusxm.com/privacy> ("**Privacy Policy**") and

may be used as permitted pursuant to the Privacy Policy, and may also be used as determined by Sponsor in connection with the administration of the Sweepstakes (including winner notification and provision of winners' names when requested).

**12.
