arbitration by sending a letter (an "Arbitration Opt-Out Notice") to Sirius XM Radio Inc., 1221 Avenue of the Americas, 35th Floor, New York, New York 10020; Attention: General Counsel: SiriusXM & Pandora Present Luke Combs Arbitration Opt-Out. The Arbitration Opt-Out Notice must include (1) your first and last name; (2) your postal mailing address; (3) phone number; (4) email address; and (5) a clear statement that you do not wish to resolve disputes with Sirius XM through arbitration. The Arbitration Opt-Out Notice must be received no later than thirty (30) days from the date you entered the Sweepstakes. The Arbitration Opt-Out will apply only to Claims arising under this Sweepstakes and it not a general arbitration opt-out of all Claims with Sponsor or any Released Party.
