

# SiriusXM Event Ticket Giveaways

## OFFICIAL RULES

The SiriusXM Events ticket giveaway promotion ("**Promotion**") involves separate and distinct ticket giveaway opportunities for various Sirius XM events (each, an "**Event**"), subject to these Official Rules ("**Official Rules**").

**SPONSOR.** The Sponsor of this Promotion is Sirius XM Inc., 1221 Avenue of the Americas, 36<sup>th</sup> Floor, New York, New York 10020.

**CONDITIONS OF ENTRY / ELIGIBILITY TO WIN.** This Promotion is open only to individuals who are a legal resident of the United States, the District of Columbia, or Puerto Rico and at least 18 years of age at time of entry. By participating in the Promotion, you agree to be bound by: (i) these Official Rules, including all eligibility requirements, and (ii) all decisions of Sponsor, which are final and binding in all matters. Employees of Sponsor and its respective subsidiaries, affiliates, advertising and promotional agencies, retailers or distributors, and members of their immediate family (e.g., spouses, domestic partners, parents, children, siblings) are not eligible to win. **HOW TO ENTER.** To enter to win tickets to a SiriusXM Event in this Promotion (each, a "**Drawing**"), follow the instructions stated on Sirius XM advertisements and social media posts promoting the Event ("**Event Posts**") and associated entry pages for the Event, which will require you to provide your full name, valid email, age, city of residence, and cell phone number (each, an "**Entry Page**"), before the end of the entry period stated on the Entry Page ("**Entry Period**"). Complete satisfaction of all of the above shall be considered an "**Entry**," and the person submitting the Entry, the "**Entrant**."
