

# Treasure 2025 Tour Ticket Sweepstakes

## OFFICIAL RULES

The Treasure 2025 Tour Ticket Sweepstakes ("**Sweepstakes**") is subject to these Official Rules ("**Official Rules**").

**SPONSOR.** Sirius XM Radio LLC, 1221 Avenue of the Americas, 36<sup>th</sup> Floor, New York, New York 10020.

**CONDITIONS OF ENTRY / ELIGIBILITY TO WIN.** This Sweepstakes is open only to individuals who are a legal resident of the United States, the District of Columbia, or Puerto Rico and at least 18 years of age at time of entry ("**Entrants**"). ET on April 11, 2025 for the Los Angeles Event (as defined below) (the "**Entry Period**"). Any entries received after the Entry Period will not be considered.

Winners for the Los Angeles Event will be determined in a random drawing to be held on or about **April 11, 2025** from among all eligible Entries received for the Los Angeles Event under the supervision of Sponsor whose decisions are final and binding in all respects.
