

SiriusXM's WWE Championship Belt 2026 Trivia Challenge

OFFICIAL RULES

MUST BE A CURRENT SIRIUSXM SUBSCRIBER (U.S. ONLY) 18 YEARS OF AGE OR OLDER WITH AN ACTIVE TRIAL, PAID, OR AD SUPPORTED SUBSCRIPTION PLAN AS OF SEPTEMBER 27, 2026. U.S. LAW GOVERNS. VOID WHERE PROHIBITED BY LAW.

CONTEST PERIOD. The SiriusXM WWE Championship Belt 2026 Trivia Challenge ("**Contest**") will begin at 9:00 AM eastern time ("ET") on October 5, 2026 and end at 2:00 PM ET on October 9, 2026 (the "**Contest Period**"). The Contest shall consist of a WWE trivia challenge (each a "**Daily Contest**") to be conducted once per day during the Contest Period.

HOW TO PARTICIPATE. During the Contest Period eligible subscribers can tune in to WWE Radio channel 156 on SiriusXM, listen for the host to open up the phone lines for the Daily Contest during (1) Busted Open on Monday, October 5, 2026 between 9 AM ET and 12 PM ET; (2) Notsam Wrestling on Tuesday, October 6, 2026 between 12 PM ET and 2 PM ET; (3) Off The Ropes on Wednesday, October 7, 2026 between 2 PM ET and 4 PM ET; (4) Busted Open on Thursday, October 8, 2026 between 9 AM ET and 12 PM ET; or (5) Cheap Heat Live on Friday, October 9, 2026 between 12 PM ET and 2 PM ET, and call 877-344-4893.

Calls will be preliminarily screened for the eligibility requirements stated herein, including subscription status, age and prior prizes won. If a caller does not satisfy the stated eligibility requirements, another caller will be selected, at Sponsor's discretion. A caller cleared by this process will be considered a "**Contestant**." The first selected Contestant for each Daily Contest will be asked to answer the WWE trivia question asked by Show host. The Contestant must correctly answer the question, as determined by Sponsor in its sole discretion. If the Contestant is unable to correctly answer the question, another Contestant will be selected using the same process described above until a Contestant correctly answers the question. The alternate Contestant(s) may be given a new question to answer. The first Contestant to correctly answer the question (who has been verified as eligible in accordance with these Official Rules) will be deemed the "**Winner**" for that respective Daily Contest and shall be awarded a Prize (as defined below).

By participating in the Contest, Contestants agree not to seek, accept or use any assistance, including, but not limited to, the use of any electronic devices, the Internet, AI, apps, or other persons, when answering any questions in the Contest.

ENTRY LIMIT AND CONDITIONS: A SUBSCRIBER MAY ONLY PARTICIPATE ONCE DURING EACH DAILY CONTEST REGARDLESS OF THE NUMBER OF SIRIUS XM ACCOUNTS THEY MAY HAVE. A CONTESTANT'S NAME AND CITY PROVIDED TO THE CALL SCREENER MUST MATCH THE INFORMATION ON THE CONTESTANT'S SIRIUSXM ACCOUNT; ANY DELIBERATE MISREPRESENTATION BY THE USE OF A FALSE IDENTITY OR ALIAS WILL DISQUALIFY THAT CONTESTANT. In the event of a dispute over the identity of an Contestant, participation will be deemed made by the "Subscriber" on the verified account as defined in the SiriusXM subscriber database.
