

SiriusXM's NASCAR® Championship Trivia Contest

OFFICIAL RULES

CONTEST PERIOD. The SiriusXM NASCAR® Championship Trivia contest ("Contest") will be conducted from 11:00 AM eastern time ("ET") to 6:00 PM ET on October 23, 2025 (the "Contest Period").

HOW TO PARTICIPATE. On October 23, 2025 eligible subscribers can enter by listening to the SiriusXM On-Track and SiriusXM Speedway shows on SiriusXM Channel 90, which air from 11:00 AM ET to 2:00 PM ET, and 3:00 PM ET to 6:00 PM ET (each, a "Show"), and when a Show host promotes the Contest on air, call 866-748-5263. Each caller whose call is answered will be preliminarily screened for the eligibility requirements stated herein, including subscription status, age, prior prizes won, and availability and willingness to participate in the "head to head" round of the Contest as described below. A caller cleared by this process will be considered a "Contestant." The first two (2) Contestants who correctly identify a former NASCAR driver will be considered **Contest Finalists**.

Both Contest Finalists will then participate in a "head to head" face-off trivia competition the following day on October 24, 2025. Contest Finalists will be required to call in to The Morning Drive show on SiriusXM Channel 90 at 8:25 AM ET and answer five (5) NASCAR trivia questions. The Contest Finalist who correctly answers the most trivia questions during the "head to head" face-off trivia competition will be a "Winner." If the Contest Finalists correctly answer the same number of trivia questions, they will be asked one additional question with a numerical-based answer and the Contest Finalist that provides the closest response to the answer will be deemed a Winner. Winner is subject to eligibility verification that may occur after winning the face-off. In the event a Winner is deemed ineligible, they will be notified of their ineligibility and will not have any right to any Prize.
