OFFICIAL RULES

ENTRY PERIOD. The Welcome to Rockville Flyaway SiriusXM Sweepstakes ("**Sweepstakes**") begins at 6:00 pm Eastern Time ("**ET**") on April 23, 2026, and ends at 11:59 pm ET on April 29, 2026 (the "**Entry Period**").

To enter this sweepstakes ("**Sweepstakes**"), visit www.siriusxm.com/rockville2026 (the "**Website**") and follow the instructions to use the submission tool (the "**Submission Tool**") to respond to the Sponsor's call-to-action: "*What band are you most excited to see at Welcome to Rockville?*" Respond by either typing in the text field or using the recording tool, then fill out the online entry form (the "**Entry Form**") to complete and submit your Entry.

Entries may be displayed on a public Fan Wall. Please note that the Fan Wall has limited capacity and cannot display all Entries at once. If you do not see your Entry posted, it does not mean that it was not received.

Successful submission of all required information shall be considered an "**Entry**" and the person submitting the Entry, the "**Entrant**." Proof of submission will not be deemed to be proof of receipt. All Entries and requests become the property of Sponsor and will not be acknowledged or returned.

LIMIT 1 ENTRY PER PERSON. Multiple Entries submitted by a single person in excess of the limit shall render all such person's Entries void and ineligible.
