**HOW TO ENTER.** To enter, go to [www.siriusxm.com/ram](http://www.siriusxm.com/ram), find and follow the advertisement to fill out our online entry form from 5:00 AM Eastern Time ("ET") on August 8, 2018 to 8:00 PM ET on September 19, 2018 (the "**Entry Period**"). You can only enter this sweepstakes by online entry. Proof of submission will not be deemed to be proof of receipt. All entries and requests become the property of Sponsor and will not be acknowledged or returned. **LIMIT ONE ENTRY PER PERSON PER HOUSEHOLD:** Multiple entries submitted by a single person during the Entry Period, whether from one e-mail address or multiple e-mail addresses shall render all of such person's entries void and ineligible. Vehicle will be equipped with standard equipment and will be delivered to a RAM dealership nearest to winner's home.
