

## CONSENT & RELEASE AGREEMENT

The undersigned **SiriusXM event attendee ("Guest")** freely enters into this Consent & Release Agreement ("**Agreement**") and hereby agrees as follows:

1. Guest hereby grants to Sirius XM Radio Inc., including Pandora®, its subsidiaries, affiliates and the successors and assigns of each of the foregoing (collectively, "**SiriusXM**") the right to use the name, image and likeness, and personal statement/testimonial of Guest and any transcripts, audio, video, photographs and other recordings of Guest recorded on Tuesday December 3, 2019 or in any statement I make in connection with my attendance at a SiriusXM-sponsored event, on that date or thereafter, in any and all media, including without limitation, satellite radio, cable and satellite television, mobile telephones, internet (streaming and/or archiving for download), SiriusXM's physical and electronic newsletters, other subscriber emails and physical mailings, and as "B-roll" material in connection with media and news coverage involving SiriusXM.

2. Guest represents and warrants to SiriusXM that (a) there exists no connection between myself and SiriusXM that might materially affect the weight or credibility of any testimonial or endorsement statement I might give (i.e., a connection not reasonably expected by an audience), and I understand that if there is such a connection (e.g., that I have received payment or free SiriusXM goods or services) that I would have to fully disclose that to SiriusXM at this time and that SiriusXM would have to disclose that to its audience; (b) any testimonial or endorsement statement I might give to SiriusXM reflects my honest opinions, findings, beliefs or experience; (c) I have all the power and authority to enter into this Agreement, to grant all of the rights described in Section 1 above; and (d) the execution and delivery of this Agreement, the grant of the rights described in Section 1 above will not violate any agreement to which I am a party or of which I am aware, any federal, state or local law or regulation to which I am subject, or any right of any third party. The signatory of this Agreement represents that he or she is duly authorized and has the authority to execute this Agreement on behalf of the Guest.

3. Guest hereby releases and indemnifies SiriusXM from and against any and all damages, claims, liability and demands arising out of or in connection with any use in accordance with Sections 1 and 2 above, including without limitation, any and all claims relating to rights of publicity, invasion of privacy, defamation, libel, slander and other personal and property rights. Guest agrees not to bring or participate in any such claim or proceeding against SiriusXM.

4. Guest understands and agrees that SiriusXM is under no obligation to make any use of Guest's appearance, name, image or likeness.
